The **MIDDLESEX COMMUNITY COLLEGE BEDFORD**, the Awarding Authority, invites sealed bids from Contractors for the MCC Fire Pump Replacements Project (Bedford Campus) in Bedford, Massachusetts, in accordance with the documents prepared by **IMEG**.

The Project consists of but not limited to: Removal, disposal and replacement of three (3) fire pumps in place, including removal, disposal and replacement of associated jockey pump, fire pump and jockey pump controllers. The project also includes new electrical wiring, MI cabling and fire alarm connections to replaced equipment.

The work is estimated to cost **\$500,000**.
